

Application for Renewal: Certificate of Authorization for a Health Professional Corporation

Please note, incomplete applications will be returned.

Instructions

Before submitting your application, please ensure that the following criteria has been met:

- 1. A director, who must be a registrant of the College and authorized to sign on behalf of the corporation, has signed the application.
- 2. The same director who signed the application form has also signed the required Declaration (Section D).
- 3. You have obtained all required supporting documentation (see checklist)
- 4. Each shareholder is a registrant of the College and has signed the required undertaking (Section C). Please make as many copies of undertaking as required. Note: Holding companies are not permitted to hold shares of the professional corporation.
- 5. If more space is required in completing the application for renewal, you have attached additional pages and labelled them appropriately.

Checklist

The application is considered incomplete without the following:

Completed renewal application form signed by a director.

Undertaking (Section C of this form) completed by each shareholder of the Corporation.

Declaration (Section D of this form) signed by a director of the corporation not more than 15 days before the application for renewal is submitted to the College.

Corporation Profile Report indicating that the corporation is active, issued by the Ontario government or a service provider contracted by the the Ontario government not more than 30 days before the application for renewal is submitted to the College.

Renewal fee of \$282.50 (\$250 + HST) which can be paid after the application for renewal and supporting documents are received and approved by the College. You will be sent a link via email to pay at that time.

Only if changes have been made to the Articles of Incorporation, a copy of the amended Articles of Incorporation.

If applicable, a copy of every certificate of the corporation that has been endorsed under the *Business Corporations Act* as of the day an initial application for a Certificate of Authorization was submitted, or since the corporation's most recent application for a renewal of a Certificate of Authorization.
